West End BIZ Giveaway Official Contest Rules

- Employees of, members of the immediate family of, or those domiciled with an employee of the West End BIZ; its board and committee members are not eligible to participate. "Immediate family" is defined as parents, siblings, children or spouse.
- To be eligible to win a prize, claimant must be 18 years of age or older at the time of the contest and reside in the Province of Manitoba.
- All entries become the property of the West End BIZ, which assumes no responsibility for lost entries. The West End BIZ reserves the right, at its sole discretion, to disqualify any individual (and all of his or her entries) who tampers with the entry process.
- By participating in the "West End BIZ Giveaway" the entrant fully and unconditionally agrees to abide by these official contest rules and the decisions of the West End BIZ, which are final and binding in all matters related to the "West End BIZ Giveaway."
- By entering this contest, entrants agree that in the event they are the winning entry for the giveaway, the West End BIZ can use their name and/or photograph in any publicity or advertisement carried out by the West End BIZ, without further remuneration.
- Photos that violate or infringe upon another person's rights, including but not limited to copyright, are not eligible.. By submitting the photo, the entrant acknowledges they are the exclusive rights holder. Entrant shall indemnify and hold harmless the West End BIZ for any infringement or other action caused by Entry.
- Photos that contain sexually explicit, nude, obscene, violent or other objectionable or inappropriate content, as determined by the West End BIZ in its sole discretion, are ineligible for the Giveaway.
- The West End BIZ reserves the right to suspend, cancel or modify the contest at any time, if it determines that for any reason the contest cannot be run as originally planned or if there is any other occurrence compromising the fairness or integrity of the contest.
- The contest is subject to all applicable federal, provincial and municipal laws. Void wherever prohibited by law.

- The West End BIZ is committed to protecting your privacy. Any personal information collected from you in the course of the "West End BIZ Giveaway" will be subject to the West End BIZ Privacy Policy posted on the Website, www.westendbiz.ca. Personal information will only be disclosed and used by the Released Parties for the purpose of administering the "West End BIZ Giveaway," in accordance with these Official Contest Rules.
- On the draw dates set forth for the "West End BIZ Giveaway" contest, the West End BIZ will select the potential winner of the prize in a random draw from all eligible entries received. One draw will take place on Friday, February 10th for a \$100 gift certificate and prize gift basket. The winners will be notified through their social media account used in their entry.
- Winners must continue to comply with the Official Rules and winning is contingent upon fulfilling all requirements. Each potential winner will be required to answer a time-limited, skill-testing question

without assistance, in order to be eligible to receive their prize. Winners will be required to sign and return within 5 days of the date notice is given, a Declaration of Compliance and Release form in order to claim their prize, and to fulfill any such other requirements as determined by the West End BIZ. If there is no response or a potential winner fails to sign and return the Declaration of Compliance and Release form within the required time period, or fails to correctly answer the skill-testing question, the potential winner will be disqualified. In the event that a potential winner is disqualified for any reason, the West End BIZ may select an alternate entrant in a random draw from among all remaining eligible entries.
